4 The Parliament of Australia enacts:

5 **1 Short title**

6 This Act may be cited as the *Australian Sports Anti-Doping*
7 *Authority Amendment Act 2009*.

8 **2 Commencement**

9 This Act commences on 1 January 2010.

13 **Division 1—CEO's functions and powers**

14 **20D Chief Executive Officer**

15 There is to be a Chief Executive Officer of the ASADA.

20 **24A Appointment of CEO**

21 (1) The CEO is to be appointed by the Minister, by written instrument,
22 on a full-time basis.

23 (2) An Advisory Group member or an ADRVP member is not eligible
24 for appointment as the CEO.

25 (3) The appointment of a person as CEO is not invalid because of a
26 defect or irregularity in connection with the person’s appointment.

27 **24B Period of appointment for CEO**

28 The CEO holds office for the period specified in the instrument of
29 appointment. The period must not exceed 5 years.

1 Note: For re-appointment, see subsection 33(4A) of the *Acts Interpretation*
2 *Act 1901*.

3 **24C Acting CEO**

- 4 (1) The Minister may, by written instrument, appoint a person to act as
5 CEO:
6 (a) during a vacancy in the office of CEO (whether or not an
7 appointment has previously been made to that office); or
8 (b) during any period, or during all periods, when the CEO:
9 (i) is absent from duty or from Australia; or
10 (ii) is, for any reason, unable to perform the duties of the
11 office.
- 12 (2) Anything done by or in relation to a person purporting to act under
13 an appointment is not invalid merely because:
14 (a) the occasion for the appointment had not arisen; or
15 (b) there was a defect or irregularity in connection with the
16 appointment; or
17 (c) the appointment had ceased to have effect; or
18 (d) the occasion to act had not arisen or had ceased.

19 Note: See sections 20 and 33A of the *Acts Interpretation Act 1901*.

20 **Division 3—Terms and conditions for CEO**

21 **24D Remuneration**

- 22 (1) The CEO is to be paid the remuneration that is determined by the
23 Remuneration Tribunal. If no determination of that remuneration
24 by the Tribunal is in operation, the CEO is to be paid the
25 remuneration that is prescribed by the regulations.
- 26 (2) The CEO is to be paid the allowances that are prescribed by the
27 regulations.
- 28 (3) This section has effect subject to the *Remuneration Tribunal Act*
29 *1973*.

30 **24E Disclosure of interests**

31 The CEO must give written notice to the Minister of all interests,
32 pecuniary or otherwise, that the CEO has or acquires and that

1 conflict or could conflict with the proper performance of the
2 CEO's functions.

3 Note: If the CEO attends and participates in a meeting of the Advisory
4 Group and has an interest, pecuniary or otherwise, in a matter being
5 considered by the Advisory Group, the CEO must disclose that
6 interest to the meeting—see section 32.

7 **24F Outside employment**

8 The CEO must not engage in paid employment outside the duties
9 of his or her office without the Minister's approval.

10 **24G Leave of absence**

11 (1) The CEO has the recreation leave entitlements that are determined
12 by the Remuneration Tribunal.

13 (2) The Minister may grant to the CEO leave of absence, other than
14 recreation leave, on the terms and conditions as to remuneration or
15 otherwise that the Minister determines in writing.

16 **24H Resignation**

17 (1) The CEO may resign his or her appointment by giving the Minister
18 a written resignation.

19 (2) The resignation takes effect on the day on which it is received by
20 the Minister or, if a later day is specified in the resignation, on that
21 later day.

22 **24J Termination of appointment**

23 (1) The Minister may terminate the appointment of the CEO for
24 misbehaviour or physical or mental incapacity.

25 (2) The Minister may terminate the appointment of the CEO if:

26 (a) the CEO:

27 (i) becomes bankrupt; or

28 (ii) applies to take the benefit of any law for the relief of
29 bankrupt or insolvent debtors; or

30 (iii) compounds with his or her creditors; or

31 (iv) makes an assignment of his or her remuneration for the
32 benefit of his or her creditors; or

- 1 (b) the CEO fails, without reasonable excuse, to comply with
2 section 24E or 32; or
3 (c) the CEO is absent, except on leave of absence, for 14
4 consecutive days or for 28 days in any 12 months; or
5 (d) the CEO engages, without the Minister's approval, in paid
6 employment outside the duties of his or her office (see
7 section 24F); or
8 (e) the CEO commits an offence against section 71 or 72.

9 **24K Other terms and conditions**

10 The CEO holds office on the terms and conditions (if any) in
11 relation to matters not covered by this Act that are determined, in
12 writing, by the Minister.

13 **Division 4—ASADA's staff etc.**

14 **24L Staff**

- 15 (1) The staff of the ASADA are to be persons engaged under the
16 *Public Service Act 1999*.
17 (2) For the purposes of the *Public Service Act 1999*:
18 (a) the CEO and the ASADA staff together constitute a Statutory
19 Agency; and
20 (b) the CEO is the Head of that Statutory Agency.

21 **24M Persons assisting the CEO**

22 The CEO may be assisted:
23 (a) by officers and employees of Agencies (within the meaning
24 of the *Public Service Act 1999*); or
25 (b) by officers and employees of authorities of the
26 Commonwealth;
27 whose services are made available to the CEO in connection with
28 the performance of any of his or her functions.

1 **Division 5—Delegation**

2 **24N Delegation by the CEO**

- 3 (1) The CEO may, by writing, delegate any or all of his or her
4 functions and powers to:
- 5 (a) a member of the ASADA staff; or
 - 6 (b) an individual whose services are made available to the CEO
7 under section 24M; or
 - 8 (c) an individual appointed as a chaperone, or as a drug testing
9 official, under the NAD scheme.
- 10 (2) Subsection (1) does not apply to the power to make a legislative
11 instrument amending the NAD scheme.
- 12 (3) Paragraph (1)(c) does not apply to a function or power unless it is
13 conferred by the NAD scheme.
- 14 (4) A delegate must comply with any written directions of the CEO.

15 **Division 6—Advisory committees**

16 **24P Advisory committees**

- 17 (1) The CEO may, by writing, establish advisory committees to assist
18 the CEO in performing any of the CEO's functions.
- 19 Note: For variation and revocation, see subsection 33(3) of the *Acts*
20 *Interpretation Act 1901*.
- 21 (2) An advisory committee consists of such Advisory Group members
22 as the CEO determines.
- 23 (3) The CEO must determine, in relation to an advisory committee, the
24 terms and conditions of appointment of the advisory committee
25 members.
- 26 (4) The CEO may give an advisory committee written directions as to:
- 27 (a) the way in which the committee is to carry out its functions;
28 and
 - 29 (b) procedures to be followed in relation to meetings.
- 30 (5) An instrument made under subsection (1) is not a legislative
31 instrument.

1 (6) A direction made under subsection (4) is not a legislative
2 instrument.

12 **25A Advisory Group’s function and powers**

13 (1) The Advisory Group’s function is, at the request of the CEO, to
14 provide advice and make recommendations to the CEO on a matter
15 relating to the CEO’s functions.

16 (2) The Advisory Group has the power to do all things necessary or
17 convenient to be done for or in connection with the performance of
18 its function.

19 (3) To avoid doubt, the Advisory Group cannot give any directions to
20 the CEO.

21 **62 Division 2 of Part 4 (heading)**

22 Repeal the heading, substitute:

23 **Division 2—Advisory Group’s membership**

24 **63 Sections 26 and 27**

1 **26 Advisory Group’s membership**

2 The Advisory Group consists of at least 2, and not more than 7,

5 (1) Each Advisory Group member is to be appointed by the Minister,
6 by written instrument, on a part-time basis.

9 (2) The Minister must not appoint a person as an Advisory Group
10 member unless:

11 (a) the Minister is satisfied that the person has appropriate
12 knowledge or experience, which may include, for example,
13 knowledge or experience in:

14 (i) education and training (so as to increase awareness of
15 sports doping and safety matters); or

16 (ii) sports medicine; or

17 (iii) sports law; or

18 (iv) ethics; or

19 (v) investigative practices or techniques; and

20 (b) the person is ordinarily resident in Australia.

21 (3) The CEO or an ADRVP member is not eligible for appointment as
22 an Advisory Group member.

23 (4) The Minister must appoint one Advisory Group member to be the
24 Advisory Group Chair.

25 (5) The appointment of a person as an Advisory Group member or as
26 the Advisory Group Chair is not invalid because of a defect or
27 irregularity in connection with the person’s appointment.

- 10 (1) An Advisory Group member who has an interest, pecuniary or
11 otherwise, in a matter being considered or about to be considered
12 by the Advisory Group must disclose the nature of the interest to a
13 meeting of the Advisory Group.
- 14 (2) The disclosure must be made as soon as possible after the relevant
15 facts have come to the knowledge of the Advisory Group member.
- 16 (3) The disclosure must be recorded in the minutes of the meeting.
- 17 (4) Unless the Advisory Group otherwise determines, the Advisory
18 Group member:
19 (a) must not be present during any deliberation by the Advisory
20 Group on the matter; and
21 (b) must not take part in any decision of the Advisory Group
22 with respect to the matter.
- 23 (5) For the purposes of making a determination under subsection (4),
24 the Advisory Group member:
25 (a) must not be present during any deliberation of the Advisory
26 Group for the purpose of making the determination; and
27 (b) must not take part in making the determination.
- 28 (6) A determination under subsection (4) must be recorded in the
29 minutes of the meeting.
- 30 (7) If the CEO attends and participates in a meeting of the Advisory
31 Group, this section applies as if a reference to an Advisory Group
32 member included a reference to the CEO.

1 **33 Outside employment**

2 An Advisory Group member must not engage in any paid
3 employment that, in the Minister's opinion, conflicts or may
4 conflict with the proper performance of his or her duties.

5 **34 Leave of absence**

6 (1) The Minister may grant leave of absence to the Advisory Group
7 Chair on the terms and conditions that the Minister determines.

8 (2) The Advisory Group Chair may grant leave of absence to any other
9 Advisory Group member on the terms and conditions that the
10 Advisory Group Chair determines.

22 Violation Committee was considering a possible violation of the
23 anti-doping rules, then:

- 24 (a) the ADRVP must, if there is such a violation, make findings
25 relating to the violation; and
26 (b) a thing done by, or in relation to, the Committee in relation to
27 the possible violation is taken to have been done by, or in
28 relation to, the ADRVP.

29 **Division 6—Reporting requirements**

30 **134 Reporting requirements**

1 *Reports for periods ending after the commencement time*

- 2 (1) If:
- 3 (a) immediately before the commencement time, a law required
- 4 the ASADA or the ASADA members to provide a report
- 5 (whether financial statements or otherwise) for a period; and
- 6 (b) the period ends after the commencement time;
- 7 the CEO must provide the report, as required, for so much of the period
- 8 as occurs before the commencement time.

15 *Reports for periods ending before the commencement time*

- 20 (b) the report has not been provided by the commencement time;
- 21 the CEO must provide the report as required.

22 *Application of law to CEO*

- 23 (4) To avoid doubt, if under this item the CEO is required to provide a
- 24 report under a law, the law applies to the CEO in respect of the report in
- 25 the same way as the law would have applied to the ASADA or the
- 26 ASADA members in respect of the report.

27 **Division 7—Miscellaneous**

28 **135 Exemption from stamp duty and other State or Territory**

29 **taxes**

- 30 No stamp duty or other tax is payable under a law of a State or Territory
- 31 in respect of, or in respect of anything connected with:
- 32 (a) the transfer of a liability under this Part; or
- 33 (b) the operation of this Part in any other respect.

1 **136 Constitutional safety net—acquisition of property**

- 2 (1) If the operation of this Part would result in an acquisition of property
3 from a person otherwise than on just terms, the Commonwealth is liable
4 to pay a reasonable amount of compensation to the person.
- 5 (2) If the Commonwealth and the person do not agree on the amount of the
6 compensation, the person may institute proceedings in a court of
7 competent jurisdiction for the recovery from the Commonwealth of
8 such reasonable amount of compensation as the court determines.

9 **137 Delegation by Minister**

- 10 (1) The Minister may, by writing, delegate all or any of his or her powers
